MOMENTUM 2012 EXHIBITOR APPLICATION & AGREEMENT

Please fill out the Vendor Agreement & Vendor Information Form. Momentum has limited space available for vendors or organizations interested in displaying information or selling approved products during **MOMENTUM 2012**, September 21st -23rd, 2012 at the Hickory Metro Convention Center. Please read the agreement fully, and complete all information regarding your organization.

Remember to send in all payments with your Vendor Agreement & Vendor Information Form. A copy will be sent back to you once the agreement is approved and signed.

MOMENTUM 2012 DATES & SET UP HOURS

(Set up: Friday, Sept. 23rd, 8:00am - 2:00pm) All set up must be complete by 2:00pm on Friday.

MOMENTUM 2012 EXHIBIT HOURS

Friday, September 21st - (Doors open 4:00pm - closes 11:00pm)

Saturday, September 24th - (Doors open 8:00am - closes 11:00pm)

- 1. VENDING BOOTH SIZE:** Each booth is approximately 8' X 8' and located in the Main Hallway situated at the front of the Metro Center. The exhibit area is located in a high traffic area between the recreation area and the main entrance.
- 2. BOOTH RENTAL FEE:** Each booth space costs \$200.00 for all days of the event. This cost includes two (2) Total Event Vendor Passes, One (1) table (8' long), and two (2) chairs. Electric will be available - must request in advance. Table skirts will be available to rent and are required. You are welcome to bring your own table coverings.
- 3. TAXES:** As a vendor, you are responsible for collecting any and all applicable taxes. Momentum will not assume any responsibility for state, local, or federal inspection or taxes required.
4. It is agreed that you, the Booth Holder, will hold harmless Momentum Worship, Inc. (sponsor of the Festival) from all claims and liabilities for damage to property or injury to persons that occur in or about the rented or used booth space, or any failure to act, whether or not such condition, activity or failure shall result from negligence of the party renting or using the space.
5. Applications will be received and either approved or rejected. You will be notified by mail of our decision within two (2) weeks after receiving your application. Acceptance is based on the quality of your merchandise as well as type of merchandise. No Merchandise that has the name or logo of Momentum is allowed to be sold or given away, No food, candy or beverage items can be sold or distributed in any way by product vendors. If your application is not accepted, your rental fee will be returned.
6. There will be no cancellations after August 1st, 2012. If a cancellation should occur prior to August 1st, your deposit will be returned, minus a \$50.00 non-refundable fee. Upon receiving this application and it's subsequent approval, the Momentum management will send your copy of this application back to you.
7. The deposit due is the cost of the booth space(s) (\$200.00 per booth requested for both days), extra registrations will need to purchase tickets.
8. **INSURANCE:** It shall be the responsibility of the exhibitor to secure necessary insurance coverage. The exhibitor acknowledges that Momentum Worship, Inc. doesn't maintain insurance covering the exhibitor's property and it is the sole responsibility of the exhibitor to obtain business interruption, property damage, and liability coverage covering any such losses or claim.
